The existing fitness equipment at Lincoln High School has been in use for 30+ years and has shown significant signs of wear and tear. Many pieces of equipment are no longer functional, which limits our students' ability to engage in effective workouts.

Importance of Replacement:

- 1. <u>Safety</u>: Outdated equipment can lead to injuries. By replacing old machines, we can ensure that our students have access to safe and reliable fitness tools.
- 2. <u>Enhanced Performance</u>: New equipment will provide students with the latest technology and features, allowing them to maximize their workouts and achieve their fitness goals.
- 3. <u>Increased Participation</u>: A well-equipped fitness center can encourage more students to participate in physical fitness activities, contributing to their overall health and well-being.
- 4. <u>Alignment with Educational Goals</u>: Investing in quality fitness equipment aligns with our commitment to promoting physical education and wellness as integral components of our students' education.

As we strive to provide our students with a safe and effective environment for physical activity, we must invest in modern equipment that meets current safety standards and enhances our fitness programs. The final quotes were not available when this agenda was completed. Physical Education teacher, Tony Biolo, will bring the quotes to the BSC meeting. The estimated cost is anticipated to be around \$200,000.00.

The administration recommends approval of the investment in the Lincoln High School Fitness Center from \_\_\_\_\_\_. This new equipment will cost \$\_\_\_\_\_\_ and be funded from the 2024-25 Lincoln High School physical education budget, athletic budget, donations from booster clubs, and student activity accounts.

#### B. Church Demolition – Approval

Robinson Brothers was asked to provide a quote for the demolition of the church building at 160 8th Street in Wisconsin Rapids. The demolition price includes removing the buildings, foundations, site improvements, and backfilling the basement voids to surrounding grades (see Attachment A).

# The administration recommends approval of the Robinson Brothers' church demolition quote, which will cost \$112,000.00 and be funded from the 2024-25 fund 46 budget.

C. CESA 6 Marketing and Communication – Approval

CESA 6 will provide WRPS with 20 hours per month of communication and marketing services from January 2025 through June 2025. The initial focus will be assisting with the District's website redesign, enrollment and marking services, and school building promotion materials (see Attachment B).

The administration recommends approval of the CESA 6 proposal for the Communication and Marketing Services, which will cost \$10,200.00 and be funded from the 2024-25 School Board and Superintendent budget.

Following, please find our quote for the above-referenced project. Robinson Brothers Environmental, Inc. (RBE) proposes to supply personnel and equipment to perform the demolition and disposal of the church building and parking lot located at 160 8<sup>th</sup> Street N, Wisconsin Rapids, WI. Pricing includes demolition within the footprint of the building and the adjacent south parking area. The work will include the following:

**Demolition of Structure** 

- Submit DNR notice for demolition and pull local raze permit.
- Disconnect electrical and gas services.
- Disconnect sewer and water laterals at the lot line (does not include disconnection work in the street).
- Demolition and removal of all building materials from the footprint of the building and adjacent parking lot.
- Materials shall be recycled, salvaged, or properly disposed of. Materials not recycled or salvaged shall be disposed of at a C&D landfill and properly documented. Any salvage value from the building would become the property of Robinson Brothers.
- Concrete, brick and block materials will be recycled on-site and used to backfill the basement.
- Import additional granular fill as needed to bring the basement void back to surrounding grades. All fill and recycled materials will be placed in compacted 12" lifts.

This pricing assumes that all the work will be completed in a single phase. Asbestos testing, asbestos abatement, tree removal, erosion control installation, and restoration work (topsoil/seed/mulch or gravel) are not included.

- 1. <u>Payment Terms</u>. Unless more specific payment terms are included in this Proposal, progress payments are due periodically during the term of the work upon receipt of invoices from RBE. Final payment is due upon receipt of final invoice from RBE at the conclusion of the work. In the event RBE must take any action to defend or enforce this contract, or perfect or foreclose any lien arising out of this contract, RBE shall be entitled to recover its costs and expenses incurred, including reasonable attorney's fees, with respect to such action.
- 2. Notice of Lien Rights. FOR WORK IN WISCONSIN, AS REQUIRED BY WISCONSIN CONSTRUCTION LIEN LAW, ROBINSON BROTHER'S ENVIRONMENTAL, INC. HEREBY NOTIFIES OWNER THAT PERSONS OR COMPANIES FURNISHING LABOR OR MATERIALS FOR CONSTRUCTION ON OWNER'S LAND MAY HAVE LIEN RIGHTS ON OWNER'S LAND AND BUILDINGS IF NOT PAID. THOSE ENTITLED TO LIEN RIGHTS, IN ADDITION TO ROBINSON BROTHER'S ENVIRONMENTAL, INC., ARE THOSE WHO CONTRACT DIRECTLY WITH THE OWNER OR THOSE WHO GIVE THE OWNER NOTICE WITHIN 60 DAYS AFTER THEY FIRST FURNISH LABOR OR MATERIALS FOR THE CONSTRUCTION OR IMPROVEMENT. ACCORDINGLY, OWNER PROBABLY WILL RECEIVE NOTICES FROM THOSE WHO FURNISH LABOR OR MATERIALS FOR THE CONSTRUCTION OR IMPROVEMENT, AND SHOULD GIVE A COPY OF EACH NOTICE RECEIVED TO OWNERS MORTGAGE LENDER, IF ANY. ROBINSON BROTHER'S ENVIRONMENTAL, INC. AGREES TO COOPERATE WITH THE OWNER AND OWNERS LENDER, IF ANY, TO SEE THAT ALL POTENTIAL LIEN CLAIMANTS ARE DULY PAID.

For work in other states, any required notice of lien rights is attached as an additional page of this proposal.

- Late Payment Charge. RBE shall be entitled to add a service charge to all payments not paid when due in the amount of 1.5% of the delinquent amount per month. This is an annual rate of 18%.
- 4. <u>Supervision of the Work</u>. Direction and supervision of the working forces, including subcontractors, rest exclusively with RBE. The customer agrees not to issue any instructions to, or otherwise interfere with, the same.
- 5. Property Insurance. Customer is responsible to carry property insurance upon the entire work at the site, to the full insurable value thereof including all risks such as fire and extended coverage, theft, vandalism and malicious mischief. Customer waives all rights or claims against RBE for losses or damages to be covered by such insurance. (Customer's property insurance is separate from the insurance carried by RBE.)
- 6. <u>Additional Work</u>. In the event RBE provides any additional work, materials or services which are the responsibility of the customer, RBE shall be entitled to reimbursement of the additional cost, together with overhead and profit. Per diem charges for out-of-town workers are in addition to any quoted labor rates.
- 7. <u>Arbitration</u>. At the option of RBE, any dispute or controversy arising out of or relating to this Agreement shall be decided by arbitration which, unless the parties otherwise agree, shall be in accordance with the Construction Industry Rules of The American Arbitration Association. Judgment on any arbitration award may be entered in any court of competent jurisdiction.
