A. Grades 6-8 Science Materials Acquisition

The Science Curriculum Subcommittee reviewed and piloted potential materials to support the previously approved curriculum maps and secured several quotes from a variety of vendors. Mr. Dave Bergerson, Science Department Chairperson, will share the acquisition proposal for grades 6-8. The items requested are supplemental materials and so a public review of materials was not held.

Attachment A sets out the recommendation for the K - 12 Science education acquisition. The Council for Instructional Improvement (CII) discussed the acquisition proposal at its April 24, 2024 meeting and unanimously (24 – YES and 0 – NO) voted to recommend approval of the proposed purchases.

The administration recommends approval of the proposed 6-8 Science acquisition as presented in an amount not to exceed \$30,000 to be funded through the WRPS Referendum Curriculum budget.

B. Policy 345.5 Graduation Requirements First Reading

Wisconsin Act 60, signed into law in December 2023, requires high school students to complete at least half a credit of personal financial literacy (PFL) to graduate. The law applies to students starting high school in fall 2024, and the graduating class of 2028 will be the first to be affected. Lincoln High School already requires students to complete a half credit and that is indicated in the current policy. However, some policy language is outdated and will be stricken from the current policy. In addition, updates to the discrimination language are included. The draft of the updated policy is included as Attachment B.

The administration recommends approval of Policy 345.5 Graduation Requirements, as presented, for First Reading.

C. Grades K-5 ELA/Reading/Handwriting Materials Acquisition

Members of the Elementary Language Arts Curriculum Subcommittee as well as elementary classroom teachers have spent the greater part of the 2023-24 school year piloting and selecting instructional materials that adhere to the provisions of Wisconsin's recently passed Act 20. Ms. Roxanne Filtz, Director of Curriculum and Instruction, and Ms. Jennifer Wilhorn, Assistant Director of Curriculum and Instruction and District Reading Specialist, will be present to summarize the process for materials selection as well share feedback from the various committees and the community review of materials. Two community members participated in the ELA materials review held on May 22, 2024 from 2:30-5:30.

Handwriting instruction has been provided in the Wisconsin Rapids School district for many years. Grade 3 has always had a handwriting workbook, while the others grades have had spiral bound workbooks that have been created at Central Office. Copying and binding those workbooks is less than efficient and the quality of the workbooks often is not good enough to sustain daily use by our students. The administration would like to purchase handwriting workbooks from Zaner-Bloser for 1st - 5th grade students each year. The initial proposal is for a 3 year purchase of the workbooks.

The District CII discussed the acquisition proposal at a special meeting held on Tuesday, May 28, 2024. The CII voted (21 Yes, 0 No) in favor of the proposed materials purchase for 3 years for Amplify CKLA for grades K-5 at a total cost of \$578,910.82. In addition, the CII voted (21 Yes, 0 No) in favor of the 3 year purchase of Zaner-Bloser Handwriting books for grades 1-5 for a total cost of \$68,997.44.

The administration recommends approval of the proposed 3-year K-5 Amplify CKLA acquisition at a total cost of \$578,910.82 and the Zaner-Bloser Handwriting workbooks acquisition for grades 1-5 at a total cost of \$68,997.44 to be paid through the WRPS Referendum Curriculum budget.

D. 7 Mindsets Renewal

Lincoln High School and Wisconsin Rapids Area Middle School implemented the 7 Mindsets curriculum during the 2023-2024 school year. 7 Mindsets is CASEL aligned Social Emotional Learning Curriculum. We are looking to extend our contract for the 2024-2025 school year at a cost not to exceed \$39,000. This cost will include the 7 Mindsets curriculum and their "BASE Education" platform. BASE provides personalized learning pathways for students needing Tier 2 and Tier 3 support. The purchase will be made using ESSER funds.

The administration recommends approval of the proposed renewal of *7 Mindsets* for the 2024-2025 school year at a cost not to exceed \$39,000 and to be paid through ESSER III funds.

V. Updates

A. Reading Screener for Grades 6-12

Ms. Wilhorn will provide an update to the committee regarding the decision to purchase MAP Growth as the reading screener for grades 6 - 12. MAP will replace the sunsetting Reading Inventory screener that is currently being used at the secondary level and will cost \$18,060.00, which will be paid from the ESSER III budget.

345.5 GRADUATION REQUIREMENTS

In order to be eligible for a high school diploma from the Wisconsin Rapids Public School District, students must meet the following graduation requirements:

- 1. Students must earn 24 credits to graduate from Lincoln High School, and 21.5 credits to graduate from River Cities High School in grades 9-12. Students who have completed goals on the IEP or Section 504 Plan, completed individual English as a Second Language goals, completed goals on a Differentiated Plan through the Gifted and Talented program, or completed the requirements of the High School Equivalency Diploma (HSED) at River Cities High School, may also be awarded a diploma.
- 2. In order to graduate from Wisconsin Rapids Public Schools, a student must earn the following credits in grades 9-12:

- 3. In order to graduate from Wisconsin Rapids Public Schools, a student must take and pass the "Civics Exam" comprised of questions that are identical to questions that may be asked of an individual applying for U.S. Citizenship by the United States Citizenship and Immigration Services. A statement shall be included in the Individualized Education Plan (IEP) of students with disabilities stating whether or not they will take the test, and if necessary, take the test with accommodations. If a student's IEP includes a statement that it is not appropriate to administer the Civics Exam to the student, the completion of the Civics Exam is not a condition of graduation for that student.
- 4. Students transferring from non-accredited schools must attend the full senior year in Wisconsin Rapids Public Schools in order to obtain a diploma.
- 5. Students will be enrolled in a class or participating in an activity approved by the School Board during each class period of each day unless the pupil is enrolled in an alternative education program as defined by Wis. Stat. 115.28(7)(e)(1), or has exhibited a high level of maturity and personal responsibility referenced in Wis. Stat. 118.33(1)(b) and as determined by building procedures.
- 6. Exceptions to these requirements are outlined below:
 - a. Students may be eligible for early graduation in accordance with Board Policy 345.52.
 - b. Students transferring from another school system who have completed four or more semesters of course work and have made normal progress toward graduation will have their credit requirements determined by the high school principal and counseling staff. All other such transfer students will meet regular District credit requirements.
 - c. Students transferring into the District from a home-based private educational program may be eligible for a high school diploma if they have met the District credit requirements, and have successfully completed at least their full senior year in Wisconsin Rapids Public Schools.
 - d. The high school principal may determine eligibility for a diploma for students who have demonstrated a level of proficiency in required credited subjects (Wisc. Stat. 118.33(d)(2)).
- 7. The high school principal shall be responsible for ensuring that students meet the requirements necessary for high school graduation. Decisions related to requirements, graduation, or participation in the graduation ceremony is the responsibility of the high school principal. Accommodations may be made for students with exceptional educational interests, needs or requirements in accordance with established guidelines.

- 8. Participation in the graduation ceremony is a privilege. Students must comply with the established building procedures to participate. Students and their parents/guardians shall be kept informed of the students' graduation status at regularly scheduled intervals.
- 9. Any appeal of the decision made not to award a diploma would be made to the Superintendent of Schools.
- 10. The Superintendent (or his/her designee) shall be responsible for the general supervision and management of the graduation of students under this policy.

The Superintendent (or his/her designee) shall develop, review, and recommend policies so that the schools of the District can help prepare students to satisfy the criteria in this policy and otherwise implement this policy.

The Superintendent (or his/her designee) shall develop practices and procedures to inform students and parents/guardians of the policy requirements and to inform students and parents/guardians of the academic progress of students.

11. The School District of Wisconsin Rapids does not discriminate on the basis of gender, race, national origin, ancestry, creed, religion, pregnancy, marital or parental status, sexual orientation, <u>transgender status</u>, gender identity, gender expression, <u>or</u> physical, mental, emotional or learning disability or handicap <u>or any</u> other characteristic protected under State or Federal civil rights laws.
