Pursuant to Section 120.12(13) and Section 118.30(1g)(a)1 of the Wisconsin State Statutes, districts are required to provide notification surrounding pupil academic standards. This notice includes identifying the pupil academic standards adopted by the Board of Education that will be in effect for the school year. Parents will be provided notice of this information through the Wisconsin Rapids Public Schools (WRPS) website. Attachment A sets out the pupil academic standards on which the WRPS curriculum is based. Roxanne Filtz, Director of Curriculum and Instruction, will be present to answer questions.

# The administration recommends approval of the Pupil Academic Standards as presented.

B. Change to 2024-25 School Year Calendar

As a result of the School Board Listening Sessions held in May, it is suggested that WRPS changes the end date of the 2nd trimester and the start date of the 3rd trimester during the 2024-2025 school year. Currently the 2nd trimester ends on Tuesday, March 4, 2025 and the 3rd trimester starts on Wednesday, March 5, 2025 with a recordkeeping day on the afternoon of Friday, March 7, 2025. The original calendar was scheduled this way in order to keep the number of days in a trimester more equal. However, it has been requested by teachers attending the School Board listening sessions that we change the end of the 2nd trimester to Thursday, March 6, 2025, with the 7th remaining a recordkeeping day and the 3rd trimester starting on Monday, March 10, 2025. This change will make the 2nd trimester 60 days and the 3rd trimester 57 days. Since most weather related closures typically happen during the 2nd trimester, this change may help balance overall student contact days in the event of several school closure days. In addition, the recordkeeping day is attached to the proposed last day of the trimester and the trimester is not ending in the middle of a week. The proposed change is reflected in Attachment B.

The Quality Educator Committee (QEC) approves any school year calendar changes at the committee level. The QEC overwhelmingly supported the change proposed to the end of Term 2 and beginning of Term 3.

## The administration recommends approval of the proposed changes to the 2024-2025 school year calendar as presented.

C. K-5 Special Education Math Intervention Resource Purchase: Connecting Math Concepts

The District Curriculum and Pupil Services departments are preparing to purchase intervention materials for use in the elementary Special Education program, and are interested in purchasing resources for students needing additional support in math. The materials being considered for purchase are SRA's Connecting Math Concepts. Connecting Math Concepts combines facts, procedures, conceptual understanding, applications, and the development of problem solving to provide support for students who struggle with mathematics through explicit, teacher-directed instruction.

Connecting Math Concepts were piloted by Andrew Miller and Shelley Moon, Special Education Teachers at Mead Elementary, for a portion of the 23-24 school year. Both teachers saw students succeed with the program and shared the resource with their elementary Special Education Teacher colleagues, who were also interested in utilizing the program. This program would supplement the Bridges curriculum already in place for our special education students.

The administration recommends approval of the purchase of the Connecting Math Concepts program as a special education supplemental intervention program for grades kindergarten through 5th grade for a total cost of \$60,851.18 to be paid from the Special Education budget and the Curriculum Referendum budget and to be implemented beginning with the 2024-2025 school year.

- V. Updates
  - A. Reframing Behaviors Professional Development

CPI's Reframing Behaviors Professional Development platform will be implemented at every school during the 2024-2025 school year. The platform was designed to teach actionable skills that can be immediately practiced. The program presents four elements of reframing behavior. Element 1: Reframe Your Perspective is a short course on the connection between neuroscience and behavior.

Element 2: Reframe Your Awareness focuses on the importance of Self-Regulation and Interception, through the technique of Notice-Name-Navigate.

Element 3: Reframe Your Actions focuses on four practices for positive behavior support: Assume Stress Behavior First; Think Can't, Not Won't; Be Curious and Ask Questions; and Use Positive Language.

Element 4: Reframe Your Relationships introduces a series of "intentional practices" to show that building a relationship can be done without a major effort.

CPI will train one person from each building to be the "Facilitator." The Facilitator will go through a 1-day training, will introduce and provide professional development training to the staff. The platform is available to every staff member assigned to each school.

WRPS has been identified as having significant racial disproportionality in special education identification and discipline and is required to set-aside 1% of our IDEA formula funds to pay for activities that will address root causes of the disproportionality. This set-aside is called "Comprehensive Coordinated Early Intervening Services" or "CCEIS." The cost is \$3,000 per school or \$2,000 per school if purchased district-wide. WRPS receives one free school since Steve Hepp served on the customer panel during the development of the program. Total cost of implementing the program at all 12 WRPS schools will be \$22,000 which will be paid out of the CCEIS funds.

### **NOTICE** of Student Academic Standards in Effect for 2024-2025 School Year

Academic Standards are statements that identify what students should know and be able to do. Standards serve as goals for teaching and learning. Academic Standards constitute only part of the curriculum. Once standards are identified, a curriculum must be developed that helps students meet and go beyond the standards. Curriculum includes standards, essential questions, benchmarks, instructional strategies, activities, resources, and assessments.

Wisconsin Rapids Public Schools (WRPS) utilizes a committee process to identify standards and develop curriculum. A committee exists for each discipline. After the curriculum is developed, it is presented to the WRPS Council for Instructional Improvement and Board of Education for approval. Curriculum is studied and revised on a ten or seven year cycle. Curriculum Committees may utilize standards from one or several state and/or national organizations, including all or parts of the standards. WRPS curriculum committees generally rely on state standards promulgated by the Wisconsin Department of Public Instruction. The chart below indicates what set of standards each WRPS curriculum committee utilized in developing their most recent curriculum.
